CALENDAR CALL:

There will be a Calendar Call on April 15, 2024, at 9:00 am of cases to be tried for the week of April 15, 2024.

JURY TRIALS:

Division 3 of Gwinnett Superior Court will convene at 9:00am on April 15, 2024, for disposition of Civil Jury/Bench Trials hereinafter listed. The cases will be called for trial in order as listed, with the exception of any case marked as Specially Set For Trial, which will be called first.

ANNOUNCEMENTS: All attorneys and pro se parties with cases listed on this calendar MUST make an announcement to Angela McCarthur via email at Angela.McCarthur@gwinnettcountry.com by 12:00 NOON, Friday April 12, 2024. This announcement shall provide the following information: 1. Case Number; 2. Name and telephone number of attorney trying the case (and for which party); 3. Estimated length of trial; 4. If a court reporter is needed (see fee information below). 5. If a court appointed interpreter is needed & specify language. Cases that fail to make an announcement will be considered abandoned and may be dismissed for want of prosecution.

DEADLINES: Pre-Trial orders shall be filed 3 weeks prior to the commencement of trial. Motions in Limine shall be filed 2 weeks prior to the commencement of trial.

JURY CHARGES: For those actions appearing on the “ready list,” counsel shall send proposed Jury Charges to Lisa Wofford via email at, Lisa.Wofford@gwinnettcountry.com prior to the start of the trial week or on Monday of the trial week at the latest.

CONTINUANCES: No Continuances will be granted for trial as all counsel have previously notified the Court that they are ready for trial.

DISMISSALS AND SETTLEMENTS: If a settlement is reached prior to April 15, 2024, please bring settlement paperwork to Court on April 15, 2024, to be reviewed by the Judge. No one is excused until all settlement paperwork has been approved and signed by the

judge. Any dismissal shall be submitted to the Clerk and a copy forwarded to Angela McCarthur. Settlement paperwork must be approved by the Court BEFORE your case may be removed from the calendar. Similarly, in the event your case is settled in court, all settlement paperwork must be approved by the Court BEFORE you are excused from court.

COURT REPORTER: The Court will make every effort to secure the presence of a Court Reporter for the civil jury trial week. Be prepared to make immediate payment at the time 'take down' is completed, via cash or attorney check. However, all attorneys and parties are placed on notice that you may be required to secure your own court reporter if the Court is unable to provide one for you during the trial week.
