CONTINUANCES

Pursuant to Rule 8.5, Uniform Court Rules, continuances WILL NOT BE GRANTED BY AGREEMENT OF COUNSEL OR BY TELEPHONE. A motion for continuance must be filed with the Clerk of Court at least ten (10) days before the call of the calendar and copy addressed to the calendar clerk. Such a request shall include the reason the continuance is necessary; the length of time requested (30, 60, days e.g.); whether the opposing party consents; any continuance(s) previously granted, to which party and for what reason; and a proposed order. Continuances will only be granted by email or Order.

SETTLEMENTS AND DISMISSALS



Counsel must supply an extra copy of all exhibits, which must be marked, to the Judge at call of trial. **Motions in Limine and Deposition objections are to be exchanged between counsel and any which cannot be agreed to must be submitted to the Court one week before the first day of the trial calendar.** This court will only hear Motions on the morning of trial which parties have discussed and been unable to resolve.
