Conflict notices which do not conform to these requirements will not be considered.

CONTINUANCES

Continuances WILL NOT BE GRANTED MERELY BY AGREEMENT OF COUNSEL OR BY TELEPHONE. All requests for continuance must be submitted, IN WRITING (whether by pleading or email to the address listed below) and must be received by the Court at least five (5) days prior to the call of the calendar. Requests shall contain the following information: 1. Reason for requesting the continuance; 2. Length of time to be continued; 3. If opposing Counsel or party agrees to continuance; 4. If continuances have previously been granted. It is the responsibility of the requesting party to ascertain if a continuance has been granted and to notify all parties and witnesses.

DISMISSALS AND SETTLEMENTS

If the parties announce a settlement or dismissal in lieu of appearance at the calendar, the Court requires that the dismissal or settlement announcement be filed, with courtesy copy transmitted to the Court, within thirty (30) days after the call of the calendar. Failing same, the case will be dismissed for want of prosecution.
