For cases in which damages are liquidated, a Motion for Default Judgment may be submitted as contemplated under USCR 15 prior to the call of the calendar, but **Plaintiff is still required to appear for the calendar (via ZOOM)** unless the Court enters a final judgment prior to the calendar.

For cases in which damages are unliquidated, Plaintiff must present evidence to prove damages. In those cases where Plaintiff is unprepared to go forward, or fails to appear, the Court may dismiss the case for want of prosecution.
