It is the responsibility of the requesting party to ascertain if a continuance has been granted and to notify all parties.

**TRIALS:** All cases on the calendar are subject to being called for trial. **Beginning Thursday, July 3, 2025**, there will be a daily recording after 3:00 p.m. of the cases required to appear the next day. **Counsel and Pro Se litigants should call that recording line daily after 3:00 p.m., at (770) 822-8654.**
