If your case is completely resolved and ready for final adjudication, your court appearance can be avoided and your case finalized through filing of a MOTION FOR JUDGMENT ON THE PLEADINGS. A motion for Judgment on the Pleadings is an option only available to attorneys. Parties representing themselves must attend the scheduled court hearing. Counsel/Parties SHOULD HAVE A FINAL DECREE PREPARED and ready to present at the trial of your case.

On JANUARY 1, 2007, Georgia's new Child Support guidelines went into effect. The new law applies to **ALL** child support decisions made after January 1, 2007. The parties/attorneys involved in these types of cases **MUST** submit the Georgia Child Support Worksheet and the accompanying Schedules to the Court before the trial date noted on the attached calendar.
