There will be a Calendar Call on April 29, 2025, at 9:00 AM of cases to be tried during the week(s) of June 09, 2025, at 9:00 AM.

*No defendants are excused from appearing in person except by permission of the Judge. **Any announcement by the State or the Defense of ready for trial means there are NO PENDING SUBSTANTIVE MOTIONS that need to be heard or ruled upon by the Court prior to trial.*** Filing of any substantive motions after the announcement of ready at trial are subject to being DISMISSED by the Court as UNTIMELY FILED. An announcement of Ready means your witnesses are available and ready for trial and there are no outstanding discovery disputes that need to be resolved by the Court. Emails are not sufficient to notify the Court of any conflicts in appearing for the trial weeks. All Counsel are ordered to file a proper conflict letter with the Clerk of Court complying with the Uniform Superior Court Rules.

JURY TRIALS:

Division 3 of Gwinnett Superior Court will convene at 9:00 am on June 09, 2025, for disposition of Criminal Cases hereinafter listed. The cases will be called for trial in order as listed, however, any statutory speedy trial demand cases may, in the Court's discretion, move to the top of the list for trial. CONTINUANCES: Can only be granted by the Judge. No continuances will be considered or granted by the Court by telephone or email. Counsel must file a written motion, filed with the clerk, and copied to the Court. A defendant residing out of state, out of county, or working out of county is NOT grounds for an automatic continuance or excusal from appearing in person at both calendar call and for trial.

PLEAS: NO NEGOTIATED PLEAS will be taken by the court once the case has been called in for trial during any trial week. All negotiated pleas must be scheduled prior to the trial week and accepted by the Court prior to being called in for trial during any trial week. If not scheduled and accepted by the Court prior to the trial week, it will either be a NON-NEGOTIATED plea, a trial, or some other non-trial disposition to resolve the case.
