**JURY/BENCH TRIALS:**

Division 3 of Gwinnett Superior Court will convene at 9:00 AM on September 8, 2025, for disposition of Civil Jury Trials hereinafter listed. The cases will be called for trial in order as listed, with the exception of any case marked as Specially Set For Trial, which will be called first.

**ANNOUNCEMENTS:** All attorneys and pro se parties with cases listed on this calendar **MUST** make an announcement to Angela McCarthur via email at [Angela.McCarthur@gwinnettcounty.com](mailto:Angela.McCarthur@gwinnettcounty.com) by 12:00 NOON, Thursday September 4, 2025. This announcement shall provide the following information: 1. Case Number; 2. Name and telephone number of attorney trying the case (and for which party); 3. Estimated length of trial; 4. If the case requires a jury trial or bench trial; 5. If a court reporter is needed (see fee information below); 6. If a court appointed interpreter is needed & specify language. Cases that fail to make an announcement will be considered abandoned and may be dismissed for want of prosecution.

**DEADLINES:** Pre-Trial orders shall be filed 10 days prior to the commencement of trial. Motions in Limine shall be filed 10 days prior to the commencement of trial.

**JURY CHARGES:** Counsel/Parties shall send proposed Jury Charges to Senior Staff Attorney Lisa Wofford via email at, [Lisa.Wofford@gwinnettcounty.com](mailto:Lisa.Wofford@gwinnettcounty.com) prior to the start of the trial week or on Monday of the trial week at the latest.

**CONTINUANCES:** No Continuances will be granted for trial by email or telephone as all counsel/Parties have previously notified the Court that they are ready for trial. In the event you wish to make a request for continuance, it shall be filed with the Clerk of Court and a courtesy copy provided to the Court. You will still be required to appear in court as scheduled to have the Motion For Continuance addressed on the date of the hearing and all attorneys of record and pro se parties shall be ready to proceed with trial in the event the motion for continuance is denied by the court.

**DISMISSALS AND SETTLEMENTS:** If a settlement is reached prior to September 8, 2025, please bring FINAL settlement paperwork to Court on September 8, 2025, to be reviewed by the Judge. No one is excused until all FINAL settlement paperwork has been approved and signed by the judge. Final settlement paperwork means an order that finally disposes of the case on the docket instanter. Any dismissals of any cases shall be submitted to the Clerk of Court and a copy forwarded to Angela McCarthur via electronic service. Settlement paperwork must be approved by the Court BEFORE your case can be removed from the calendar and before anyone can be excused from appearing as scheduled. Similarly, in the event your case is settled in court, all FINAL settlement paperwork must be approved by the Court BEFORE any attorneys or pro se parties will be excused by the court from the reporting calendar.

**COURT REPORTER:** The Court will make every effort to secure the presence of a Court Reporter for the civil jury trial/bench trial week. The fee is approximately \$44.00 per hour (or \$22.00 per hour if cost is shared between two parties.) Be prepared to make immediate payment at the time 'take down' is completed, via cash or attorney check. However, all attorneys and parties are placed on notice that you may be required to secure your own court reporter if the Court is unable to provide one for you during the trial week. Cases will not be continued if you fail to secure the presence of a court reporter.

Cases should report to the Gwinnett Justice and Administration Center, Court Room 3G, 75 Langley Drive, Lawrenceville, Georgia at 9:00 a.m. on Monday, September 8, 2025. All attorneys and parties must appear in person. No Zoom appearances shall be permitted for attorneys, parties, or witnesses.
