Any announcement by the State or the Defense of ready for trial means there are **NO PENDING SUBSTANTIVE MOTIONS** that need to be heard or ruled upon by the Court prior to trial.* The filing of any substantive motions after the announcement of ready for trial at Calendar Call are subject to being DISMISSED by the Court as UNTIMELY FILED. *An announcement of Ready means your witnesses are available and ready for trial and there are no outstanding discovery disputes that need to be resolved by the Court.* Emails are not sufficient to notify the Court of any conflicts in appearing for the trial weeks. All Counsel are ordered to file a proper conflict letter with the Clerk of Court complying with the Uniform Superior Court Rules for filing any conflicts in appearing for trial.

LEAVES OF ABSENCE:

Leaves of absence must be filed **PRIOR TO THE NOTICE AND PUBLISHING OF THIS TRIAL CALENDAR TO BE CONSIDERED TIMELY FILED BY THE COURT**. Any leaves of absence filed by counsel AFTER the Notice and Publishing of this calendar that includes any of the dates of the scheduled trial weeks are **SUBJECT TO BEING DENIED** by the Court pursuant to the Uniform Superior Court Rules.

JURY TRIALS:


Division 3 of Gwinnett Superior Court will convene at 9:00 am on September 15, 2025, September 22, 2025, and September 29, 2025, for disposition of Criminal Cases hereinafter listed. The cases will be called for trial in order as listed, however, any statutory speedy trial demand cases may, in the Court's discretion, move to the top of the list for trial. Requests to Charge should be filed with the Clerk of Court and a courtesy copy emailed to Senior Staff Attorney Lisa Wofford at lisa.wofford@gwinnettcourt.com no later than Monday of trial week at 9:00 a.m.

CONTINUANCES: Can only be granted by the Judge. No continuances will be considered or granted by the Court by telephone or email. Counsel must file a written motion, filed with the clerk, and copied to the Court and opposing counsel. A defendant residing out of state, out of county, or working out of county is NOT grounds for an

automatic continuance or excusal from appearing in person at both calendar call and for trial. Only the Judge can excuse Defendants from any scheduled court appearance.

PLEAS: No NEGOTIATED PLEAS will be accepted by the court once the case has been called in for trial during any trial week, even if the case is not reached for trial. All negotiated pleas must be scheduled prior to the trial week in which the case is called in for trial and must be accepted by the Court prior to being called in for trial during any trial week. If not scheduled and accepted by the Court prior to the trial week, it will either be a NON-NEGOTIATED plea, a trial, or some other non-trial disposition to resolve the case. This includes the case being rolled over to a subsequent criminal jury trial week not listed on this calendar. The Court does NOT hold pre-trial conferences with counsel to determine if a recommended plea offer will be accepted or rejected by the Court.
