All Counsel are ordered to file a proper conflict letter with the Clerk of Court complying with the Uniform Superior Court Rules for filing any conflicts in appearing for trial.

PLEAS: No NEGOTIATED PLEAS will be accepted by the court once the case has been called in for trial during any trial week, even if the case is not reached for trial. All negotiated pleas must be scheduled prior to the trial week in which the case is called in for trial and must be accepted by the Court prior to being called in for trial during any trial week.
