FAILURE TO TIMELY FILE SAID WORKSHEETS, CHILD SUPPORT ADDENDUM, AND/OR PARENTING PLAN MAY RESULT IN A CONTINUANCE OF THE FINAL HEARING AND/OR BEING HELD IN CONTEMPT.

TRIAL APPEARANCE

Pursuant to Rule 8.4 of the Uniform Court Rules, the Parties and Counsel on this Calendar shall be prepared to appear ready for trial. Should any of the actions settle or otherwise be removed from the Calendar, the next one in sequence shall be moved up. **UNLESS PREVIOUSLY EXCUSED BY THE COURT, ALL PARTIES ON THE ATTACHED CALENDAR MUST REPORT IN PERSON AT 9:00 A.M. ON MONDAY, AUGUST 24, 2026.** The Court shall determine the order in which cases will be heard after the call of the calendar. The Court will provide as much notice as possible to the parties on the calendar; however, at a minimum, all parties are expected to be ready for trial and will be subject to a **two (2) hour notice**. Unless otherwise advised, Counsel and Parties must be able to respond and appear ready within two (2) hours from the call.

DISMISSALS AND SETTLEMENTS

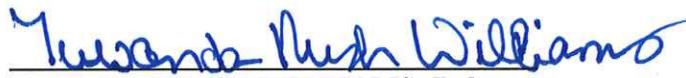
CONTINUANCES

Pursuant to Rule 8.5 (Uniform Rules for Superior Courts), continuances WILL NOT BE GRANTED MERELY BY AGREEMENT OF COUNSEL OR BY TELEPHONE. This Court requires that all requests for continuance must be submitted, in pleading form, and must be filed with the Clerk of Court at least five (5) days prior to the call of the Calendar. If mailed, send it to the address listed below. Requests shall contain at least the following information: Reason for requesting the continuance; if continuances have previously been granted, to which party and for what reason; and Order for Judge's signature in the event the request is granted. It is the responsibility of the requesting party to ascertain if a continuance has been granted and to notify all parties. Note: Continued cases will lose calendar position.

PURSUANT TO SB 132, AMENDING O.C.G.A. §9-11-58, ALL PROPOSED FINAL ORDERS MUST BE ACCOMPANIED BY A COMPLETED CIVIL CASE DISPOSITION FORM, A COPY OF WHICH IS ATTACHED TO THIS CALENDAR, IN ORDER FOR THE CLERK TO ENTER THE FINAL JUDGMENT.

General Civil and Domestic Relations Case Disposition Form Instructions

1. Provide the class of court and county in which the case is being disposed.
2. Provide the plaintiff's and defendant's names.
3. Provide the reporting party who is the individual completing the form.
4. Provide the attorneys' names and Bar numbers. If parties represented themselves, provide their names and check the self-represented box.
5. Provide the manner of disposition by checking the appropriate box. See below for definitions.
6. Provide an answer to the three questions by checking the appropriate boxes.

Manner of Disposition Definitions

Jury Trial: Cases in which a jury is impaneled to determine the issues of fact in the case. A jury trial should be counted when the jury has been sworn, regardless of whether a verdict is reached.

Bench/Non-Jury Trial: Cases in which a judge or judicial officer is assigned to determine both the issues of fact and law in the case. A bench/non-jury trial should be counted when the first evidence is introduced, regardless of whether a judgment is reached.

Non-Trial Disposition: Cases in which the disposition does not involve either a jury trial or a bench trial.

Alternative Dispute Resolution: If a case was disposed of via a non-trial disposition, and the method of disposition was alternative dispute resolution. Only check if the whole case was resolved via alternative dispute resolution.
