**ARE YOU BEING ABUSED?**

- Are you afraid of your partner?
- Do you apologize for your partner’s behavior?
- Does your partner put you down/call you names?
- Do you have to account for your daily activities?
- Have you ever been injured by your partner?
- Has your partner ever threatened you?
- Do you avoid friends or family to avoid conflict?
- Have you ever been forced to have sex?
- Does your partner prevent you from getting a job?
- If you work, does your partner control the money?
- Does your partner blame you for the abuse?

If you recognize any of these symptoms of abuse,

**YOU ARE NOT ALONE.**

If you are in an abusive relationship, KNOW:

- people get injured, sometimes even killed,
- children who witness violence are damaged,
- the abuser’s behavior is NOT YOUR FAULT,
- the abuse WILL NOT STOP without help,
- HELP IS AVAILABLE.**

## **AN ABUSER'S POTENTIAL TO KILL (Lethality Assessment)**

Following are indicators used in making an assessment of an abuser's potential to kill.

1. THREATS of homicide or suicide.
2. Recent or threatened SEPERATION.
3. JEALOUS – accusations of cheating.
4. Used or threatened with a WEAPON.
5. STRANGULATION.
6. Forced Sex.
7. VIOLENT to OTHERS/children.
8. Damaged your belongings/pets.
9. DEPRESSION/Desperation.
10. ALCOHOL or DRUG abuse.

### **SAFETY PLANNING**

These suggestions do not guarantee, but may improve your safety.

### **SAFETY BEFORE YOU LEAVE**

Have a charged phone at all times. Don't be afraid to call the police.

Identify your partner's use and level of force so you can assess danger before it happens.

If violence occurs, avoid kitchens/bathrooms (potential weapons), and rooms with no windows/doors (no escape).

If violence is unavoidable, make yourself a small target; dive into a corner, curl up into a ball, cover head/face with arms.

Don't run to where your children are located, they may get injured too.

Teach your children how to get help. Tell them not to get involved in the violence and not to tell the abuser about the plan.

Let trusted friends and neighbors know and plan with them. Tell neighbors to call the police if they hear suspicious noises coming from your home.

Create several plausible excuses for leaving home.

Practice how to get out safely with your children.

Back the car in and leave it fueled, and unlocked. Hide an extra set of car keys and change of clothes.

Gather important documents (bank accounts, birth certificates, insurance and medical records, etc.) and keep them in a safe place outside your home.

Decide where you will go if you need to leave and pick more than one place you know will be safe.

### **SAFETY AFTER YOU LEAVE**

Change the locks/get an unlisted phone number.

Change routes/times of traveling to work/school.

Get a dog, security system, and take a self- defense course.

Alert your workplace of your situation and have your calls screened, if possible.

Get caller ID and call block so no one can get your new unlisted phone number.

Find a support group for you and counseling for your children.

Inform your friends and neighbors and ask them to be on the lookout. Show them a recent photo of the abuser.

Get a Temporary Protective Order (TPO).

### **TEMPORARY PROTECTIVE ORDERS (TPO)**

Only STALKING or DOMESTIC VIOLENCE victims can file for a TPO. There must be a recent act or threat of physical violence. The petition must be filed in the county where the STALKER/BATTERER lives.

**There is no charge to apply for a TPO.**

A protective order can:

- \*Direct a party to refrain from acts of violence.
- \*Grant a spouse possession of the residence.
- \*Order assistance in retrieving personal property.
- \*Exclude (evict) the abusive spouse from the home.
- \*Require a party to provide alternative housing.
- \*Grant temporary visitation/custody of children.
- \*Order a party to pay child or spousal support.
- \*Grant possession of personal property (ex: car).
- \*Order a party to stop harassing the other.
- \*Grant court costs and attorney's fees.
- \*Order parties to undergo psychological counseling.

Always keep a copy of the TPO with you.  
Call the police immediately if the TPO is violated.  
Get extra copies for family, school, work, etc.
